Welcome to Tasman Holiday Parks

As part of our Tasman Promise, it's important to us that you are welcomed to a clean, safe place that allows you to relax and unwind. So, for the safety of you, your family, friends and our other guests, please take a moment to read our park guidelines below. Should you have any questions please let a member of staff know and they'll be happy to assist.

Relax, settle in and enjoy your Tasman holiday.

ARRIVAL/DEPARTURE: You are free to arrive from 2pm until we close reception. All accommodation and sites are to be vacated by 10am on day of departure. If you would like to make alternate arrangements, please see our team at reception prior to arrival or scheduled departure time.

SPEED LIMIT: All roads in the property are shared between vehicles, pedestrians and kids on bikes and scooters. All roads have a walking pace speed limit of 8km/h unless signposted otherwise.

NOISE: Please be respectful of others and their enjoyment within the park by restricting noise from music, televisions, and social gatherings between 10pm and 6am.

PARKING: One car space has been allocated for each site. Please park in this space and not on or across roadways.

CHILDREN: All children in the park are the responsibility of their parent or guardian. All children under 12 must be accompanied by an adult when using the amenities, playgrounds, pool areas and other park facilities. We require all children to be back at their registered accommodation or site by 9.00pm.

BUNK BEDS: Children under 9 years of age should not use the top bunk and children should also not play on the top bunk.

BICYCLES/SKATEBOARDS/SCOOTERS/ROLLERBLADES: Are to be used in daylight hours and only on roadways. These items are not to be used in or around park facilities such as the laundry, amenities buildings, playgrounds etc. Other out of bounds areas including the entrance to the park, will be outlined by our team at reception.

PLAYGROUNDS: Use of the playground may result in serious injury including Death, head, eye or spinal injury, paralysis, broken limbs or strains. Risks include falls and collisions with other users and hazards associated with gaps, openings, and protruding objects.

VISITORS: All visitors will need to register on arrival at reception prior to entering the park. All visitors must leave the park by 8pm. Additional day use charges may apply.

DUMP POINT: See park map or reception team for location. Please do not use amenity blocks.

FIRES: No open fires are to be lit at any time.

PETS: Small pets will be allowed at certain times during the year and only on camp sites. Pets must not be left unsupervised and must be kept on a lead or in a contained area at all times. Aggressive dogs that may put guests or our staff at risk are prohibited. We may ask you to remove your dog from the park if the dog attacks or if the dog seems unsafe to be in the park. Please contact the park prior to arrival to discuss bringing your pet on holiday with you.

SMOKING: Is not permitted in any accommodation or common areas.

EMERGENCY: For any emergency cases relating to fire, police or ambulance please contact 000. After hours assistance by park management will be available. Please ring reception, which diverts to our emergency afterhours numbers if reception is closed.

RISK WARNING: Park management wishes to warn all persons who engage in any activity for recreation, enjoyment, leisure or relaxation that the pursuit of such activities may result in harm or serious personal injury. All persons who engage in such activities do so at their own risk. Children and infants must be supervised by an adult at all times.

UNAUTHORISED ACTIVITIES: Antisocial behaviour, illegal drug use, excessive use of alcohol, undue mess around site, unregistered vehicles, undue noise, acts of violence, smoking in accommodation, driving lessons and conducting business onsite are prohibited from occuring on the property. Failure to comply with any of above, including any damage caused to the property may result in eviction from the property.

SKYDECK: Our Skydeck is open daily from 9.00am - 9.00pm. Please note all children under 12 must be supervised by an adult. Maximum occupancy at any time is 108 people. Please see reception if you'd like further information.




